Our Program

The mission of the Community Reintegration Services Program (CRSP) is to assist individuals in their transition out of the justice system. CRSP empowers clients to make sustainable personal changes that positively impact individuals, families, and our community.

Services of CRSP include employment readiness, assistance with meeting basic needs, life skills, and connecting to social support, based on the individual's goals. This program is collaboration between the Department of Corrections, Delaware Center for Justice, Inc, and multiple community partners in the state of Delaware.

The goal of the re-entry program is for case managers and participants to work together to:

- Establish participants' goals for a successful transition out of the justice system
- Assist individuals with overcoming barriers to success
- Link participants to necessary community resources and services

All programs and services at DCJ are offered free of charge.

How can the Program Help?

The CRSP take a whole-person approach to case management, connecting program participants with services and resources to improve the individual's overall wellness, and reduce the risk of re-offending. Case managers and participants discuss each individual's history and current needs, and together they create a plan to work on the individual's goals.

This program can assist with or help participants access:

- GED/high school diploma
- College or certificate programs
- Vocational training programs
- Social services
- Housing
- Basic needs (food, clothing, ID, etc.)
- Job readiness skill building, job search, and employment
- Family support services
- Substance abuse services & mental health services
- Healthcare

Our Workshops & Classes

The CRSP provides workshops and classes geared towards building ex-offenders' skills in a variety of areas. Currently, the CRSP offers programs at DOC facilities, including probation offices:

“Get My Mind Right” is an interactive group that addresses the social, emotional, and environmental factors involved in the re-entry transition. The weekly meeting topics are focused on several of the criminogenic risk factors that are most commonly associated with negative behavior and recidivism.

The CRSP “Dollar and a Dream” Job Club is designed to help participants with criminal backgrounds identify and obtain a career by assisting with resume writing, interviewing techniques and preparedness, job search skills, and more.
